## **AFFIDAVIT OF MARGARET ROSS**

I, (Affiant) MARGARET ROSS, resident of HC 49 BOX 242E, PORCUPINE, SD 57772, County of OGLALA LAKOTA, State of SOUTH DAKOTA makes the following statement, testimony and General Affidavit under oath or affirmation, in good faith, and under penalty of perjury, of sincere belief and personal knowledge that the following matters, facts, and things set forth are true and correct, to the best of my knowledge and belief:

That on or about August 5th, 2018, it was brought to my attention, specifically and explicitly that Peri Pourier was not a resident of District 27, that she was currently living in Rapid City and that it was understood that she was not legally fulfilling the definition of residency for candidacy. At that time, I was approached by a member of Peri Pourier's inner circle, seeking confirmation of legal language regarding residency requirements for candidacy according to state law. The person seeking that information admitted openly at that time that Peri Pourier was not living in District 27, but was living in Rapid City.

And that on or about August 15th, I, Maggie Ross, had a direct conversation with Red Dawn Foster and Kevin Killer regarding Red Dawn Foster and Peri Pourier's non-resident status during which Red Dawn Foster confirmed to me that A) Peri Pourier was not living in District 27, and B) that Red Dawn herself was hoping to sell property in Rapid City in order to finance the purchase of a home or modular dwelling to move to 3 Moccasin Park Road in Pine Ridge in order to fulfill her sworn testimony and given address on her candidate filing. Red Dawn Foster then openly admitted that she was not living in District 27.

And that on multiple occasions since August 1st, 2018, members of the Democrat Party including former State Senator Kevin Killer confronted me, Maggie Ross, about the source of information cited above and demanded that I reveal the identity of witnesses who gave me information about Peri Pourier and Red Dawn Foster's non-resident status. When I refused to provide the names of said witnesses, Kevin Killer and other Democrat Party members attempted to intimidate and influence me to avoid further public comment about my personal knowledge and personal conversations regarding Peri Pourier and Red Dawn Foster's resident status and their ineligibility for the election process, attempting to convince me not to speak to media or to public officials about the things I know and have been told per direct conversation with Red Dawn Foster, acknowledging Pourier and Foster's lack of compliance with Constitutional mandate of two year residency prior to election eligibility.
